BYK Regulatory Information

DISPERBYK-162

Wetting and dispersing additive for solvent-borne coatings and pigment concentrates. Particularly suitable for stabilizing carbon blacks as well as organic pigments, especially in two-pack PU wood and furniture coatings.

Europe	<u>Swiss Ordinance 817.023.21, Annex 10</u> This product is conform with the compositional requirements of the part for printing inks for packaging of the Swiss Ordinance 817.023.21 (Version of 1 December 2019). The monomers/starting substances for manufacturing the active components and all other components are listed in Annex 10. Specific migration limits apply. Therefore, the product can be recommended for food contact printing inks in Europe.
Industry	<u>Nestlé Guidance Note on Packaging Inks (Oct. '18)</u> According to the recipe, the product does not contain any of the substances listed in Table 1 – Table 7 of the Nestlé Guidance note on Packaging Inks (dated October 2018). However, the solvent toluene, which is listed in Table 6, and 2-methoxy-1-methylethylacetat and ethylbenzene, which are listed in Table 7, are present.

EuPIA Exclusion List (Nov. '16 – Corrigendum Dec. '18)

According to the recipe, none of the substances listed in Annex 1 (Group C – G) of the EuPIA Exclusion List (November 2016 - Corrigendum Dec. 2018) are present. The product itself is not classified and labeled with any of the Hazard Statements given in Group A and B.

General Remarks

Regulations apply within the context of respective regional framework regulations, e.g. Regulation (EU) No. 1935/2004 and FDA 21 CFR 174.5. Since traces of unknown processing aids cannot be fully excluded, compliance with general requirements is the responsibility of the end user.
