Physicochemical hazards arising from the chemical

Specific hazards during fire fighting : Do not allow run-off from fire fighting to enter drains or water courses.

Special protective equipment and precautions for fire-fighters

Special protective equipment for fire-fighters : Wear self-contained breathing apparatus for firefighting if necessary.

Specific extinguishing methods : Collect contaminated fire extinguishing water separately. This must not be discharged into drains.
