EU **Regulation (EU) No. 10/2011**

The components of this product or the monomers and starting materials used to manufacture the components of the product are listed directly in Annex I - Table I of Regulation (EU) No 10/2011 (including all amendments). Specific Migrations Limits and/or restrictions apply.

The product does not contain dual use additives or volatile solvents by purpose.

The product is covered by the compositional requirements of the BfR Recommendation XIV 'Polymer Dispersions'.

China **GB9685-2016, Table A.1 'Plastics'**

The product does not comply with the National Food Safety Standard of the People's Republic of China, Standard for Uses of Additives in Food Contact Materials and Articles (GB9685-2016).
